The news reports regularly on information security breaches. In fact, the number of breaches and associated damages – in monetary penalties and to organisations' reputations – continues to rise each year. **Over £6 million** in financial penalties have been handed out by the Information Commissioner's Office (ICO) since its powers were increased in 2010.<sup>1</sup>

## The following statistics may be surprising and worrying for education providers:



Last year the education sector reported the third highest number of data breaches to the Information Commissioner's Office.<sup>2</sup>

**40% of security breaches** experienced by UK organisations are caused by simple human error and **37%** are caused by malicious attacks.<sup>3</sup>



The average cost of a data breach to UK organisations has more than doubled since 2008.<sup>4</sup>

A government survey estimates that more than a quarter of the UK's adult population have fallen victim to identity theft.<sup>5</sup>



A Department for Business Innovation & Skills survey showed that the majority of large organisations (**81%**) had a security breach last year (the corresponding figures for SMEs was **60%**).<sup>6</sup>

## Every educational institution needs a plan to protect confidential information.

It's likely you have sensitive information in your files that includes student, pupil and staff names, addresses, medical information and birth dates, as well as reports, banking and financial data. Unless you take steps to properly protect this information, you may be opening the door to prosecution and monetary fines, identity theft and even criminal fraud. Today, it's more than just good practice to protect sensitive data – it's the law. **A sound data security plan should include these five essential elements:**

- ✓ **Take stock:** Establish what types of confidential information your organisation holds.
- ✓ **Scale down:** Keep only the information you really need. The Data Protection Act specifically states that personal information should only be gathered and used for legitimate purposes and not be kept beyond its useful life.
- ✓ **Lock it up:** Make sure information you hold is kept secure at all stages of its life, whether in electronic or hard copy.
- ✓ **Plan ahead:** Create a plan in the event a security breach does happen. The ICO provides specific guidance on its website [ico.org.uk](http://ico.org.uk).
- ✓ **Destroy it:** The ICO recommends shredding confidential paper documents when no longer needed. Make sure you use a secure and documented shredding process conducted by security experts.
