# The Challenge

Everyday, IVC clinics provide treatment and care to thousands of our furry, hairy and scaly friends - over 8.5 million animals over the year.

Across IVC's multi-site UK portfolio, group practices generate a significant amount of confidential documents that must be handled in accordance with local laws and regulations including GDPR.

To comply with data protection laws, IVC needed an effective document process that helped make sure that the large quantities of confidential documents they handle daily were securely destroyed. They also needed a coherent system that provided a stress-free solution for their complex data management and responsibility to manage their customers' data - helping practice staff to do what they do best: outstanding animal care.

## **Objectives**

- IVC needed to work with a data security expert to ensure they could effectively dispose of their confidential documents.
- IVC then initiated a thorough tendering process to find a supplier who could help them handle this. Shred-it's quality of service and pricing shone through and were awarded the contract.

# Approach
